Bulgin Limited (including the Arcoelectric brand), as a manufacturer of articles, is reliant on our supply chain to ensure that the substances/articles we use comply with REACH and POP Regulations.

Our articles, based on our knowledge at this point in time, comply with the substance restrictions listed in Annex XVII of Regulation (EC) 1907/2006 REACH and Annex I and II of Regulation (EU) 2019/1021 POP, these do not contain any of the 13 substances on the SVHC Candidate List dated October 28<sup>th</sup> 2008, nor any of the 12 substances added to the SVHC Candidate List dated January 13<sup>th</sup> 2010, nor acrylamide added to the SVHC Candidate List, dated March 30<sup>th</sup> 2010, nor any of the 8 substances added to the SVHC Candidate List dated June 18<sup>th</sup> 2010, nor any of the 8 substances added to the SVHC Candidate List dated December 15<sup>th</sup> 2010, nor any of the 7 substances added to the SVHC Candidate List and 1 substance reviewed dated June 20<sup>th</sup> 2011, nor any of the 20 substances added to the SVHC list dated December 19<sup>th</sup> 2011, nor any of the 13 substances added to the SVHC list dated June 18<sup>th</sup> 2012, nor any of the 54 substances added to the SVHC list dated on December 19<sup>th</sup> 2012, according to article 59 (1,10) of regulation (EC) No. 1907/2006(REACH) in a concentration above 0.1% weight by weight. Nor any of the 6 new substances added to the SVHC list dated June 20<sup>th</sup> 2013, nor any of the 7 new substances added to the SVHC list dated December 16<sup>th</sup> 2013, nor any of the 4 new substances added to the SVHC list dated June 16<sup>th</sup> 2014, nor any of the 6 substances added to the SVHC Candidate List and 1 substance reviewed dated December 17<sup>th</sup> 2014, nor any of the 2 substances added to the SVHC Candidate List dated June 15<sup>th</sup> 2015, nor any of the 5 substances added to the SVHC Candidate List dated December 17<sup>th</sup> 2015, nor Benzo[def]chrysene added to the SVHC Candidate List dated June 20<sup>th</sup> 2016, nor any of the 4 substances added to the SVHC Candidate List dated January 12<sup>th</sup> 2017, nor Perfluorohexane-1-sulphonic acid and its salts added to the SVHC Candidate List dated July 7<sup>th</sup> 2017, nor any of the 7 new substances added to the SVHC Candidate List dated January 15<sup>th</sup> 2018, nor any of the 10 new substances added to the SVHC Candidate List dated June 27<sup>th</sup> 2018, this is with the exception of Lead (pb) which may be contained in some of our articles in a concentration > 0.1% by weight as an alloying element or ceramic parts in piezoelectronic components, nor any of the 6 new substances added to the SVHC Candidate List dated January 15<sup>th</sup> 2019, in this case we will inform our customers in accordance with Article 33 of the REACH regulation, nor any of the 4 substances added to the SVHC Candidate list dated July 16<sup>th</sup> 2019, nor any of the 4 substances added to the SVHC Candidate list dated January 16<sup>th</sup> 2020, nor any of the 4 substances added to the SVHC Candidate list dated June 25<sup>th</sup> 2020, nor any of the 2 substances added to the SVHC Candidate list dated January 19<sup>th</sup> 2021, nor any of the 8 substances added to the SVHC Candidate list dated July 8<sup>th</sup> 2021, nor any of the 4 substances added to the SVHC Candidate list dated January 17<sup>th</sup> 2022.
